GENERAL INSTRUCTIONS

Rygel Gly Wetter Plus Surfactant will assist wetting of plant surfaces, giving more uniform spray coverage and increased retention of the applied spray. Measure the required amount of **Rygel Gly Wetter Plus Surfactant** and add to the spray tank near the end of the filling process to minimise foaming.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

Dangerous to fish. Do not contaminate ponds, streams, rivers or waterways with the chemical or used container.

STORAGE AND DISPOSAL

Store in the closed original container in a cool, well ventilated area. Do not store for prolonged period in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler of designated collection point.

If not recycling, break, crush, or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers to below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

SAFETY DIRECTIONS

Will irritate the eyes, nose, throat and skin. Avoid contact with eyes and skin. When preparing product for use, wear elbow length PVC gloves, overalls and face shield. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water.

FIRST AID

If poisoning occurs, contact a doctor or Poisons Information Centre (Tel: Australia 13 11 26). If swallowed, do NOT induce vomiting. Give a glass of water.

If skin contact occurs, remove contaminated clothing and wash skin thoroughly.

If in eyes, hold eyes open, flood with water for at least 15 minutes and see a doctor.
